- 6. I declare that I have minimum 4-year didactic experience in conducting lectures not included in basic didactics for students of foreign universities, e.g. during summer schools, intensive courses.
- 7. I declare that I have been an author of at least one publication in the scope of "Mathematical Modelling Techniques in the last four-year period.
- 8. I declare that I have proficient command of English (it refers only to non-native speakers of English).
- 9. I declare that I have read the description of the object of the contract, I raise no objections, I have acquired information necessary to prepare this tender and I undertake to satisfy all the requirements of the Contracting Authority.
- 10. Having got familiar with the content of Article 297 §1 of the Polish Penal Code: "Whoever, in order to obtain from a bank or organisational unit conducting economic activity in compliance with the law, or from a body or institution being in receipt of public funds a credit, a bank loan, guarantee, warranty, letter of credit, subsidy or public procurement, confirmation by a bank of an obligation under a guarantee or warranty or a similar financial provision for a specific economic aim, an electronic payment instrument or public order, submits a document that is forged, altered, attests falsehoods or is dishonest, or a dishonest written statement concerning circumstances of essential importance for obtaining the said financial support, payment instrument or order) and Article 297 amended by Article 1 item 12 of the 18 March 2004 Act (Dz.U.
