

## DESCRIPTION OF THE SUBJECT OF THE ORDER

University of Silesia invites all the interested parties for submitting an offers (according to the attached model) for a **transport service performed in the Russian Federation in the Region of the Polar Ural.**

### **1. The subject of the order is:**

- transport service outside the Polish borders – transport of 4 members of the geological expedition and equipment (400 kg) in the area of field research in the subpolar conditions in the Central Mountains of PaiKhoi (Kara River Valley and the region).
- Place of start and end of the trip (as in point 2): Workuta.  
Travel stages: Stage I - transport of the geological expedition from Workuta to the area of research in the Central Mountains of PaiKhoi (Kara River Valley and the region) and return to the Workuta (about 400 km), Stage II – getting out of Workuta to the area of research and return transport of the expedition to Workuta (about 400 km). Number of kilometers to overcome: about 800 km.
- Purchaser requires that the total value of services offered by the Contractor include all other costs necessary for the proper performance of the service. In particular: the price of the vehicle, rental, fuel, tolls etc. driver's salary, the vehicle insurance and other costs necessary to comply with the order. The vehicle must be adapted to the tundra conditions (according to the attachment – or equivalent).
- Precondition: providing a replacement transport in case of breakdown of the vehicle in the shortest possible time, not longer than 24 hours.

### **2. The Purchaser requires the transport Service consisting of:**

- Transport of people and equipment on 10.06.2014. from Workuta to the area of field research in the subpolar conditions in the Central Mountains of PaiKhoi (Kara River Valley and the region) indicated by the Purchaser.
- Organizing the return transport after about 14 days from the place described above to the Workuta.

### **3. Estimated term of the order realization:**

- Departure from Workuta to the area of field research in the subpolar conditions in the Central Mountains of PaiKhoi (Kara River Valley and the region) – 10.06.2014
- Return from the place described above to the Workuta – ab. 24.06.2014

### **3. Place of execution of the order:** Russian Federation – Polar Ural

### **4. Number of participants:** by the Purchaser side – 4 and the equipment weight – approx. 400kg

### **5. Conditions for participation in the proceeding of the Contractor:**

- A Statement according to the Attachment number 1.

### **6. Settlement:**

The settlement will take place at the end of the service. The Purchaser agrees to make the payment onto the Contractor's account indicated on the invoice/ bill within 21 days from the date of acceptance by the Purchaser duly issued financial document.

The Purchaser reserves the right to cancel or withdraw from the award of the contract without giving any reason.
